On Saturday evening, Deputy Assistant to President Bush and Director of Intergovernmental Affairs in Washington D.C, Ruben Barrales, spoke by teleconference with the CCAWV Board of Directors offering his assistance and a phone number when we might need the assistance of the federal government. We were further, fortunate to have both the President of the National Association of Counties, Hon. Bill Hansell and the President of the National League of Cities, Hon. Jim Hunt spoke to our group. President Hansell is a County Commissioner from the State of Oregon and President Jim Hunt is City Councilman from our own Clarksburg, West Virginia! We appreciate their efforts to visit and share information with us. Also, thanks to each of you who took time from your busy schedule to join us, we had 50 of 55 counties represented!



During the annual meeting, attendees had the opportunity to participate in round table discussions with experts on various issues including the Tax Modernization Project. As the project continues, the Secretary of the Department of Revenue has assembled the "Tax Modernization Work Study Group, a team of individuals from the Office of the Governor, the Department of Revenue, which includes the Office of the Secretary, the State Tax Department and the State budget Office and economists from Marshall University and West Virginia University in their continued efforts to thoroughly review the current tax structure. They have also formed a subcommittee for the purpose of focusing on Local Taxation/Property Tax. Pocahontas County Commissioner Reta Griffith, CCAWV Board member will represent CCAWV on this subcommittee. The sub-committee focus will be to determine methods of generating additional or new revenue sources for local governments.



Addressing the Finish Line

The West Virginia Statewide Addressing and Mapping Board (WVSAMB) presented its plan for completion of the statewide addressing project. The board had previously terminated its addressing contractor for the project.

County 9-1-1 directors, addressing coordinators and county commissions from all 55 counties were invited to the meeting. Over 100 attendees filled the meeting room to capacity at the Days Inn in Flatwoods. Featured speakers included Brigadier General Ralph Pasini USAF (retired), a West Virginia University graduate who is currently Assistant Vice President at Michael Baker Jr., Inc., and Stan Cavendish, President of Verizon West Virginia. Verizon provided \$15 million to fund the project beginning in 2001.



Craig Neidig, WVSAMB Chairman, emphasized the Board's commitment to finishing the project. "The counties and 9-1-1 directors are to be commended for their efforts to get the project to the stage it is at today. But there is still a lot of hard work to be completed and continued participation by local government is essential to achieve success. All those involved in this project are deeply dedicated to finishing what we started. That is no less than the world-class, state-of-the-art mapping and addressing system for West Virginia that we originally envisioned."

As those attending the annual meeting are aware, Secretary of State Betty Ireland announced that the Regional Jail Authority has rescinded their request for approval of "emergency rules." This is good news for county government. Although we understand that some rule changes may be necessary, there is no "emergency situation." Emergency rules should not be pushed through quickly, but rather legislative rules should go through the legislative process of open and extensive debate and the opportunity for counties to participate in the discussion.

COURTHOUSE REFLECTIONS

Sketches by Larry McCallister, Calhoun County Commissioner



JEFFERSON COUNTY COURTHOUSE

The first courthouse built on this site in 1803 was destroyed by fire. In 1836 a new and larger building was erected. It was in this structure that the famous abolitionist, John Brown, and his associates were tried and sentenced to be hanged for treason in 1859. During the Civil War the building was partially destroyed by shell fire. When it became evident that Jefferson County would be part of the Civil War battleground, valuable papers and records were sent to Lexington, VA. The county records were thus preserved almost intact. In 1865 the county seat was moved to Shepherdstown where it remained until 1871 when it was returned to Charles Town. Authorities then decided to rebuild the Courthouse and the work was completed in December of 1872, at a cost of \$18,500 but additional refurbishing increased the total to \$21,179.18.

Colonel Charles Washington, brother of George Washington, gave the land on which the courthouse stands as a gift to the town. A metal tablet on one corner honors the memory of Colonel Washington, for whom Charles Town was named. Today the courthouse contains wills, deeds, and papers of many of the Washington family.
