Just a quick report on October legislative interims...

The committee on interstate cooperation reviewed proposed legislation for an electronic filing system for property tax. The committee is seeking feedback from counties and the bar association of the proposal.

First Lady Gale Manchin reported to the Joint Economic Development Committee on the work of the Governor's Job Council. Experts have been meeting to link education to economic development and progress is being made.

Judiciary Committee A heard further presentation from entities seeking legislation to allow the retail sale of liquor by the bottle on Sunday in West Virginia. Seems that all 5 surrounding states allow Sunday sales in some form or the other.

West Virginia County Records Management and Preservation Grants Program Accepting Applications for FY 2007-2008 Projects

The County Records Management and Preservation Grants Program, administered by the Records Management and Preservation Board (RMPB), mailed the grant package with the guidelines, priorities and grant applications to County Commission presidents September 1, and available on line at <http://www.wvculture.org/history/rmpb/rmpb.html> the same day. The RMPB will be accepting applications from county commissions in behalf of county offices for projects to implement records management programs, with the deadline being November 1. Grants are offered in support of the program's dual purpose of preserving the county records of West Virginia and of maintaining the accessibility of those records for the public. This is the fourth annual grant cycle. In the first three RMPB has made available \$1,156,595 for 63 records projects in 34 counties. Projects have provided funding for back-up preservation microfilm, proper disposition of many records exceeding the required retention period, new and improved filing and storage systems, improved preservation storage containers and binders, and the development of county records management plans.

RMPB funding priorities in this cycle are for projects to:

1. Conduct inventory of records and remove non-records and accumulations of records, such as justice of peace books, personal property books and duplicate land books, having reached or exceeded required retention periods from file rooms, vaults and storage areas, particularly attics and basements.
2. Conduct complete records inventory and condition assessment of all county records and storage areas, and develop a master records management plan for the county, under the direction of a certified records manager.
3. Provide for the proper and improved storage of and access to permanent records or records with required retention periods in excess of twenty-five years.
 - A. Physical storage: Provide proper and improved storage units and systems, such as mobile track shelving systems, steel shelving, and/or standard archives records boxes (10"x12"x15").
 - B. Security/preservation microfilm, with digital imaging combination for enhanced access: Create microfilm, the preservation eye-readable format, which will be required as the security backup to be maintained offsite in proper environmental conditions. Projects to reformat original paper records to digital image must also include creation of preservation/security backup microfilm to be maintained offsite in proper environmental conditions.

The grant program does not provide grant funds for electronic/computer equipment purchases. Funds available for grants in the fourth cycle are estimated to be between \$250,000 and \$300,000. The RMPB will make no more than fifty percent of the available grant funds or \$150,000 for reformatting projects in the third priority.

Annexation

The changes made to the annexation laws in 2001 with respect to the election and petition methods of annexing have had negative results for counties and the constituents they represent. CCA supports legislative change that would add accountability and cooperative reasoning to the process.

Regional Jail Costs

The cost of housing inmates in regional jails is rising and requiring more and more taxpayer dollars. CCA supports all methods of jail cost relief, from reviewing management practices to cost-sharing by all arresting entities.

Tax Issues

CCA will watch the Governor's Tax Modernization Project initiative very carefully and will continue to participate in discussions. CCA will support changes to current tax laws that have a positive affect on County Government and the taxpayers we represent.

The Regional Jail Oversight Committee heard from Fayette County Sheriff Bill Laird regarding Fayette County's 10 month old Community Corrections Day Report Center. RJA Oversight Committee Chairman Senator Shirley Love complemented Sheriff Laird and Fayette County for creating a model program for the rest of the state. While Sheriff Laird could not give a specific dollar amount for the savings to Fayette County, he assured that the overall results have been very positive and the program has had an 80% success rate of participants. RJA executive director Wyetta Fredericks reported to the committee that the stakeholders interested in maximizing the fee collections and contain jail costs were continuing to meet and come up with ideas and proposed legislation. (CCAWV has been participating in these meetings.)

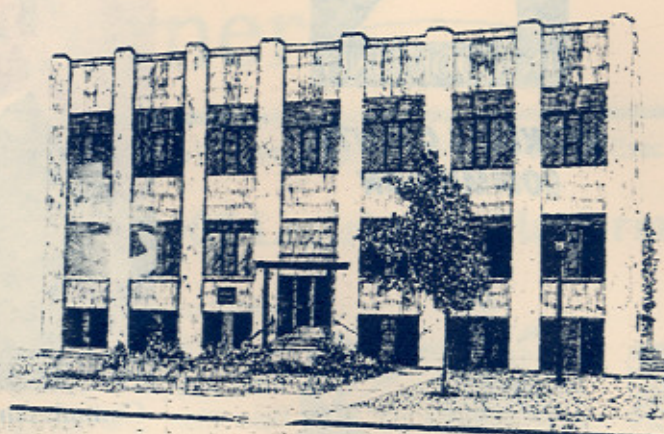

PRESTON COUNTY COURTHOUSE

The Preston County Court House is located off U.S. Route 7 in Kingwood, West Virginia. The contract for construction of the courthouse was awarded to the P.W. Johnson Construction Co. in October, 1933. The new building was built on the site of the former Court House which burnt, and as such much of the salvageable material from the old building was used and most of the furnishings refinished and used in the new building. The total cost, including building, equipment and ground work, was near \$113,500. It was built with buff-colored Indian limestone. The style is Art-Deco. The dedication day of the new Court House was held on Saturday, August 25, 1934.
